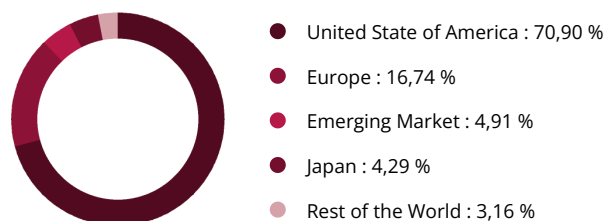
## Investment allocation

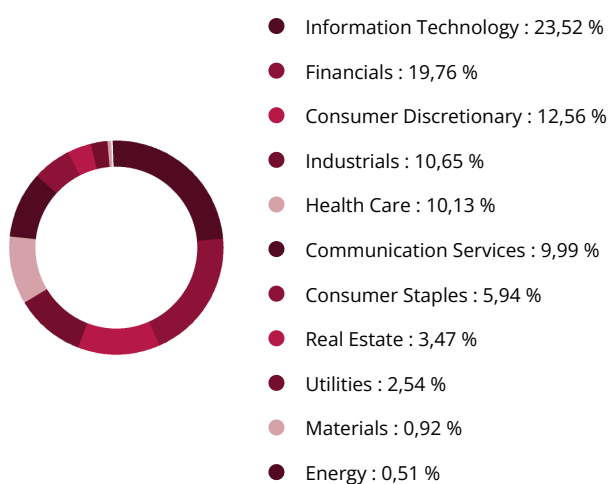
## Geographical breakdown of the equity investments

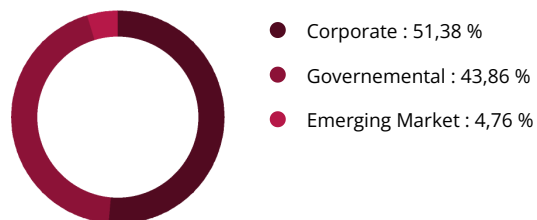
## Sector breakdown of the equity investment

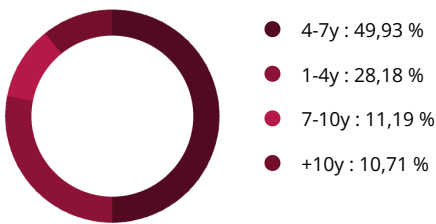
## Breakdown of the fixed income investment
