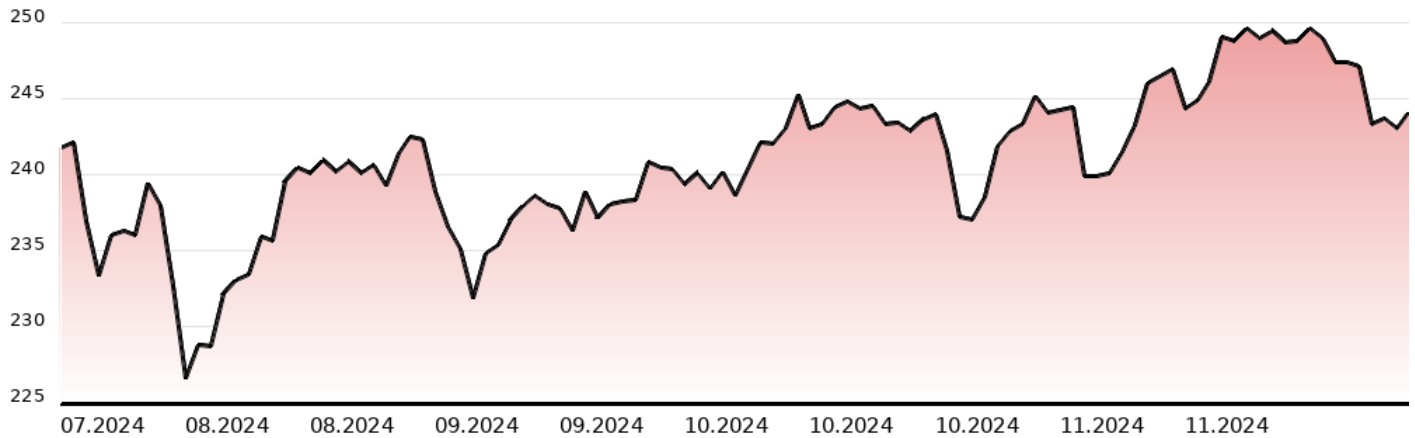

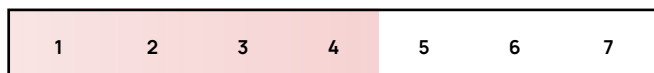
Price Evolution

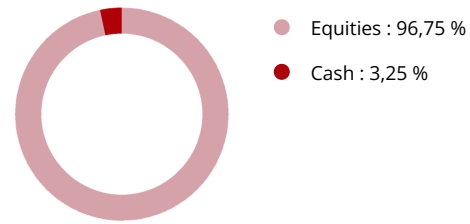

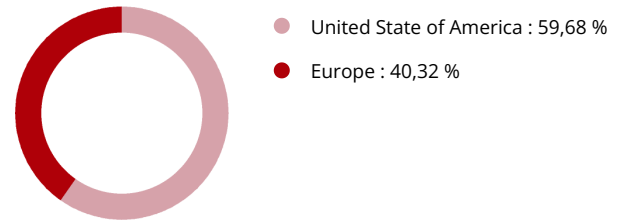

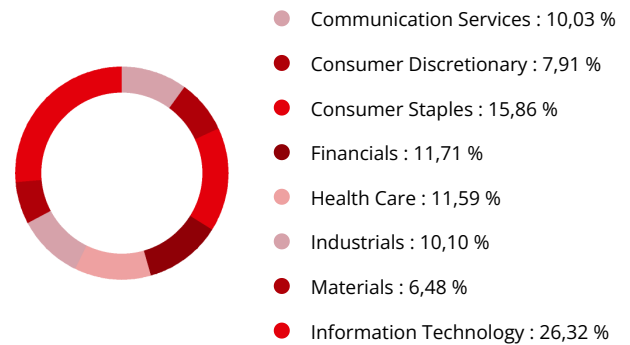
Geographical breakdown of the equity investments
