### What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### Objectives

The objective of the sub-fund is to achieve medium- and long-term capital growth through the investment in international equities, while allowing the investor to contribute to an environmental impact.

The sub-fund has sustainable characteristics within the meaning of Article 8 of the SFDR. The sustainable investment objective and sustainable investment strategies are detailed in the prospectus.

The sub-fund invests its assets mainly in equities issued by companies domiciled and/or listed in OECD member states. The securities are mainly denominated in EUR and USD. The sub-fund dynamically aligns itself with the criteria recommended by the taxonomy of the European Union and applies the best practices of use on the market in order to contribute to the mitigation of and adaptation to climate change while taking care not to cause significant harm to other environmental objectives. As a result, the sub-fund invests in companies seeking to improve their environmental footprint while ensuring their compliance with social criteria, which are assessed through an external ESG data provider.

The sub-fund benefits from an internal methodology designed especially for this fund by Spuerkeess Asset Management S.A.. For this method, Spuerkeess Asset Management S.A. calls on external service providers to obtain data. This data is then processed by the management company and the sub-fund manager according to the internal methodology. The management company Spuerkeess Asset Management S.A. and the fund manager are responsible for assessing the qualitative data. The selection is then made by the fund manager. A minority share of the sub-fund's assets (up to 33% of its net assets) may include securities of issuers domiciled and/or listed in emerging countries, as well as other instruments authorised under point III.1.A)1.1 of the prospectus with an emphasis on "emerging markets".

The sub-fund does not use derivatives.

**Benchmark:** The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

The sub-fund is particularly suitable for an investor looking to participate in the evolution of international equities, especially those of companies which the manager considers to contribute to the energy transition and which are managed according to environmental, social and governance responsibility criteria. The sub-fund is suitable both for individual investors looking to invest in the equity market and for sophisticated investors looking to achieve their predefined investment objectives. The sub-fund is particularly suitable for medium and long-term investments, as capital losses may occur due to stock market fluctuations.

The class M is open to investors whose shares are subscribed under a discretionary management mandate exercised by a financial intermediary.

#### Other information

**Depository:** Banque et Caisse d'Epargne de l'Etat, Luxembourg

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

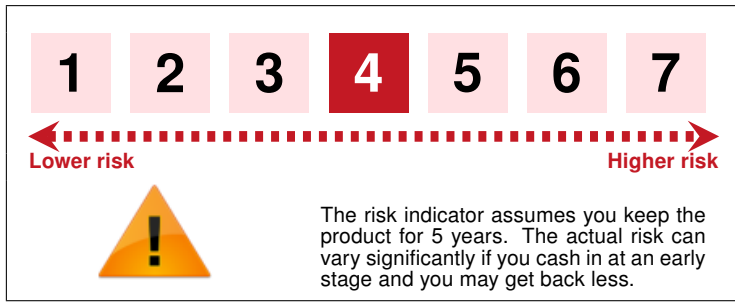

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

**Be aware of currency risk.** You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, Counterparty risk, Operational risk.

## What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
