What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to achieve medium- and long-term capital growth through direct and/or indirect investment in shares issued by companies whose activity is mostly in different predefined global economic sectors selected and weighted by the manager on the basis of their expected profitability.

The sub-fund invests its assets:

- mainly in shares issued by companies whose activity is mostly in the following sectors: Information Technologies, Materials, Healthcare, Financials, Industrials, Consumer Discretionary, Consumer Staples, Utilities, Real Estate, Telecommunications, Energy. The allocation to a given sector on this list may vary between 0% and 100% of the securities portfolio. These investments may be made directly and/or indirectly (for example through sectorial or global equity UCIs/UCITS);

- up to 25% of its net assets in other assets authorised under point III.1.A)1.1 of the prospectus (including shares and UCIs/UCITS other than those mentioned above, bonds, money market instruments and term deposits). The Sub-Fund's assets may comprise a minority share (up to 33% of its net assets) of securities of issuers domiciled and/or listed in emerging countries, as well as UCIs/UCITS and/or other instruments authorised under point III.1.A)1.1 of the prospectus with an emphasis on "emerging markets".

A minority share of the sub-fund's assets (up to 33% of the net assets) may include securities of issuers domiciled and/or listed in emerging countries, as well as UCIs/UCITS and/or other instruments authorised under point III.1.A)1.1 of the prospectus with an emphasis on "emerging markets".

The sub-fund may, for the purposes of good management and/or hedging, use all of the derivative financial instruments (for example, currency forwards, futures, options, etc.) and other techniques/instruments set out in the Investment Restrictions, within the limits provided for.

The sub-fund will at all times, directly and indirectly, invest more than 50% of its assets in equities in accordance with the investment policy.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is particularly suitable for an investor looking to participate in the performance of the stock markets. The sub-fund is suitable both for individual investors looking to invest in the equity market and for an investor wishing to achieve his predefined investment objectives. The sub-fund is particularly suitable for medium and long-term investments, as capital losses may occur due to stock market fluctuations.

Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

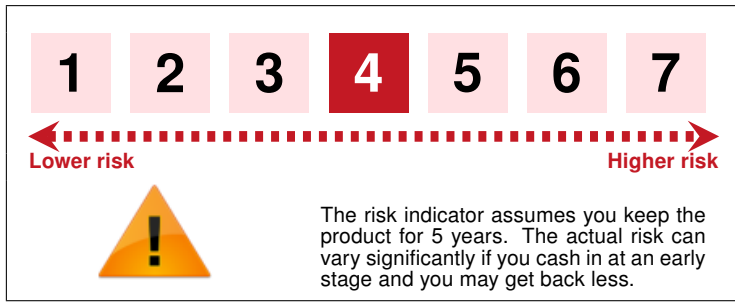

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, Counterparty risk, Operational risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 EUR is invested

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
