## What is this product?

Type This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### Obiectives

The objective of the sub-fund is to achieve medium- and long-term capital growth by investing mainly in quality companies that also demonstrate good social and governance practices.

The sub-fund invests its assets:

mainly in equities issued by companies domiciled and/or listed in OECD Member States. These investments may be made directly and/or indirectly (for example through UCIs/UCITS equity funds);

- up to 25% of its net assets in the other assets authorised under point III.1.A)1.1 of the prospectus (including equities and UCI/UCITS other than those mentioned above, bonds, money market instruments and term deposits).

A minority share of the sub-fund's assets (up to 33% of the net assets) may include securities of issuers domiciled and/or listed in emerging countries, as well as UCIs/UCITS and/or other instruments authorised under point III.1.A)1.1 of the prospectus with an emphasis on "emerging markets".

The sub-fund's strategy is based on a bottom-up selection process that aims to identify quality companies by applying a series of quantitative filters.

The notion of quality is characterised by a collection of metrics used to assess the sustainability of a company's growth (economic and financial profitability, debt, etc.).

Thus, at least 66.67% of the sub-fund's net assets are invested in a portfolio composed of quality equities as defined in the investment policy.

The manager filters according to quantitative criteria to put these exclusions into practice. The list of filters applied that may result in exclusions can be obtained on the management company's website.

The sub-fund also promotes environmental and/or social characteristics within the meaning of Article 8 of the SFDR.

The sub-fund may, for the purposes of good management and/or hedging, use all of the derivative financial instruments (such as currency forwards, futures, options, etc.) and other techniques/instruments set out in the Investment Restrictions, within the limits provided for.

The sub-fund will invest at all times, directly and indirectly, more than 50% of its assets in equities in accordance with the investment policy.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

The sub-fund is particularly suitable for an investor looking to participate in the performance of the stock markets. The sub-fund is suitable both for individual investors looking to invest in the equity market and for sophisticated investors looking to achieve their financial investment objectives. The sub-fund is particularly suitable for medium and long-term investments, as capital losses may occur as a result of stock market fluctuations.

#### Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.



**Risk indicator**

## What are the costs?

## **Recommended holding period: 5 years**
